READ ALL RULES, REGULATIONS & GENERAL INFORMATION BEFORE SIGNING APPLICATION FORM.

The Exhibitor hereby applies to CAVALCADE EVENTS LLC. for the custom auto show (referred to on cover), to have the vehicle described displayed therein, and agrees that if the application is accepted, they will display the vehicle at the show under the following terms and conditions.

1. Most shows are necessarily overbooked by 10%. In such cases where space is NOT available for an entry already accepted to the show, the Producer CAVALCADE EVENTS LLC. will have sole authority to deny entrance to the building to vehicles after the building capacity has been reached.
2. Producer CAVALCADE EVENTS LLC. has final authority to determine the following:
 - A. Location of exhibitor's display in the show.
 - B. Number and placement of lights.
 - C. Volume of stereo, P.A. or other noise.
 - D. Size and tastefulness of signs and display.
 - E. Paint work that is distasteful or objectionable will be covered up or the vehicle removed.
3. Once the Exhibitor's display and/or vehicle are set up in the show, they shall NOT be removed or concealed by the Exhibitor prior to the end of the show without the permission of the Producer.
4. Neither the Producer, the Sponsor, nor any officer, director or shareholder thereof, or the owner of the building at which the show is produced, shall be responsible or liable for any loss or damage to all or any part of the Exhibitor's display and/or vehicle, and the Exhibitor shall and does hereby waive any and all rights he may have against them or any of them for such loss or damage.
5. A ¾ front view, ¾ rear view, and an interior photo of aforesaid vehicle must accompany this application.
6. All pictures will become property of the Producer and will NOT be returned.
7. **ENTRY AND ADVERTISING RELEASE:** In consideration of this entry, the owner and spouse and guests agree to permit CAVALCADE EVENTS LLC. or its assigns, the use of their name and picture of the entered vehicle for publicity, advertising, and commercial purposes (including newspapers, magazines, radio and television) before, during and after the event, and do hereby relinquish any rights whatsoever to any photos taken in connection with the event, and give permission to publish or sell or otherwise dispose of said photographs to CAVALCADE EVENTS LLC. or its assigns. All publicity and advertising rights reserved by CAVALCADE EVENTS LLC. or its assigns.
8. **DISPUTES:** Independent Judging Officials have been hired by CAVALCADE EVENTS LLC. and will be in attendance to judge your entry. All decisions are deemed final.

GENERAL INFORMATION

HOW TO ENTER

1. Detach the Application and fill it in completely (with signature) then mail it to us with photos and proper fees included, TODAY.
2. Your application will be processed and you will be notified as to your acceptance or stand-by status by mail approximately two weeks before the show.

STANCHIONS AND DISPLAYS

1. You **MUST** supply your own stanchions. ALL materials used in your display **MUST** be fireproof. Display size **MUST** be completed on application form. Display size **MUST** be approved by the Producer. Stanchions available for rent. Must be ordered prior to show.

ELECTRICAL

1. You **MUST** supply your own lights and 12 gauge, 3-wire, heavy-duty extension cords.
2. There is a \$50.00 additional charge for electricity for entire weekend.

FIRE REGULATIONS

1. GAS CAPS **MUST** be taped or locked.
2. The hot battery cable **MUST** be disconnected and the terminal **MUST** be taped.
3. **NO ENGINE FIRING DURING THE SHOW!!**

SIGNS

1. Optional: signs by your entry with your NAME, CITY, and description of your entry's features and changes.
2. **NO COMMERCIAL IDENTIFICATION WILL BE ALLOWED IN CAR BOOTH WITHOUT COMMERCIAL DISPLAY FEE BEING PAID!!!**
